Call for Papers

Call published on Friday 26 Jan 2024 Submission deadline for abstract: Sunday 10th March 23.00 GMT, 2024 This eighth conference follows previous biennial meetings, beginning in 2012 meetings have been hosted by universities and/or music education organisations from across England. The 2024 in-person meeting will be hosted by Newcastle University.

MERYC England is a charity and is affiliated to EuNet MERYC that hosts a European conference biennially. MERYC England normally hosts its meetings on the alternate biennial years.

This one-day conference focuses on what we are learning from young children under five years old, their families and caregivers about music, and music education in today's world.

Our focus is music in young children's lives and the generation of discussion of effective approaches for listening and making music with children to support and mentor musicality in practice.

You will have the opportunity to reflect on how research and practice influences five key questions:

- What are the ways that young children's music can be seen, heard and valued?
- What musical environments help us listen with young children?
- Musical worlds what kinds of musical partners are there?
- What are the implications for practice?
- What do I need to develop my practice?

We encourage interactive participation through discussion, practical activities, dissemination of research and innovative practice relating to the field of music in early childhood (0-5 years), in education (both inside and outside school), informal learning contexts and everyday life.

We welcome abstracts from participants from the UK and Europe. These will be reviewed anonymously.

Submissions Procedure

Abstracts (350 words) should be structured according to these outlines:

Spoken Papers

20 mins presentation, plus 10 mins discussion

For empirical papers the headings should include:

- 1. Background
- 2. Aims
- 3. Method
- 4. Results
- 5. Conclusions

For theoretical/review papers, the headings should include:

- 1. Background
- 2. Aims
- 3. Main Contribution
- 4. Implications

For a spoken practice paper, the headings should include:

- 1. Theoretical background and content
- 2. Age and characteristics of participants

- 3. Aims of the project
- 4. Method or pedagogical approach
- 5. The activities
- 6. The outcomes
- 7. Conclusions and implications for future practice

Posters

Depending on the subject and/or content, it may be more appropriate to submit an abstract as a poster for visual presentation rather than a 20-minute spoken presentation. In general, the sorts of papers, which are most effective as posters, are those in which the major conclusions become evident from the thoughtful examination of charts, graphs and photos rather than those, which require the audience to follow a sustained chain of verbal argumentation. The poster paper is able to "stand alone", that is, to be understandable even if the author is not present.

For posters the abstract headings should include:

- 1. Background
- 2. Aims
- 3. Method
- 4. Results
- 5. Conclusions

Workshop - Practice demonstration

45 minutes plus 10 mins discussion

- Background
- Aims
- Interactive participation (an idea of what delegates will experience through the workshop/demonstration)
- Implications
- Specific value and meaning (indicate in four keywords the workshop's purpose, intended focus and its value for participants)
